All purchases are made **BY APPOINTMENT ONLY** (walk-in purchases are not available).

We purchase, or consign, items your children have outgrown by:

- “season” (see attached seasonal list)
- inventory needs
- based on purchaser demand

Because **Quality** over quantity is very important to us, and the customers buying your items, **we only buy:**

- Top Name-Brand Clothing
- Current Styles
- All items must be in “like new” / “gently-used” and clean condition:
You will find that we pay you a great price for your best brands in “like-new” condition.
- All parts must be in tact (applies to non-clothing items)
- Batteries must be included to show the item is in “working condition” (if applicable)

The **primary reasons we return clothing** to selling customers:

- Excessive wear on fabrics
- Stains
- Brands we don't purchase (review the attached clothing brand list)

Pre-Inspect your clothing and linen items to ensure there are no:

- Stains
- Holes
- Faded fabrics
- Excessive pilling
- Worn knees
- Missing buttons
- Broken zippers
- Hems out
- Etc.

We currently **DO NOT** accept:

- Single car seats (unless part of a car seat/stroller travel system)
- Books
- VHS videos
- Stuffed Animals
- Bathtubs
- Potty Chairs
- Diaper Pails
- Toys or equipment items that have been recalled
